

A portion of Lot 84 of East Riverside Land Company Tract, on file in Book 7 of Maps, Page 33, Records of San Bernardino County, in the City of Riverside, County of Riverside, California, being more particularly described as follows:

COMMENCING at the Southeast corner of said Lot 84;

Thence N.89°51'04"W. along the southerly line of said Lot 84, a distance of 20.00 feet, to a line parallel with and 20.00 feet westerly of the easterly line of said Lot 84, being the southeast corner of Parcel 2 as shown by Record of Survey on file in Book 40 of Records of Survey, Page 73 thereof, Records of Riverside County, and also being the southwest corner of Northgate Street as conveyed to the County of Riverside, by document recorded April 14, 1950, as Instrument No. 381, Official Records of said County;

Thence N.00°04'35"W. along said parallel line, also being the easterly line of said Parcel 2, a distance of 18.80 feet;

Thence northwesterly along a non-tangent curve concave southwesterly, having a radius of 2042.00 feet, through an angle of 01°39'13" and an arc length of 58.93 feet, to the POINT OF BEGINNING, the initial radial line bears N.05°17'08"E.;
