

EXHIBIT "A"

That portion of Parcel 2 of Parcel Map 8799 on file in Book 39, Page 88 of Parcel Maps, Records of Riverside County, described as follows:

**BEGINNING** at the northwest corner of said Parcel 2;

thence South 00°16'03" East, 259.00 feet along the westerly line of said Parcel 2;

thence North 89°43'30" East, 195.00 feet parallel with the northerly line of said Parcel 2 to a point on the westerly line of a dedication for public road purposes, recorded August 13, 1979 as Inst. No. 170511, of Official Records, said line being parallel with and 30.00 feet westerly of the easterly line of said Parcel 2;

thence South 00°16'03" East, 31.28 feet along said westerly line to the **TRUE POINT OF BEGINNING**;

thence South 00°16'13" East, 586.42 feet, continuing along said westerly line to a point on the southerly line of said Parcel 2;

thence South 89°28'15" West, 3.00 feet along said southerly line to a point on a line that is parallel with and 33.00 feet westerly of the easterly line of said Parcel 2;

thence North 00°16'03" West, 586.44 feet along said last mentioned parallel line;

thence North 89°43'30" East, 3.00 feet parallel with the northerly line of said Parcel 2 to the westerly line of said dedication, said point being the **TRUE POINT OF BEGINNING**.




