RESOLUTION NO. 20534

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE GENERAL SERVICES DIRECTOR AND THE GENERAL SERVICES ADMINISTRATIVE SERVICES MANAGER TO ACCEPT CONVEYANCES TO THE CITY OF RIVERSIDE OF INTERESTS IN REAL ESTATE AND CONSENT TO THE RECORDATION OF SUCH INSTRUMENTS AND TO CONSENT TO THE RECORDATION OF OFFERS OF DEDICATION; AND REPEALING RESOLUTION NO. 18233.

WHEREAS, the City Council of the City of Riverside adopted Resolution No. 18233 authorizing the Real Property Services Manager or the Assistant City Manager to accept for and on behalf of the City of Riverside ("City"), all deeds or grants conveying any interest in real property to the City; and

WHEREAS, Resolution No. 18233 also authorized the Real Property Services Manager or the Assistant City Manager to consent to, on behalf of the City, the recordation of all irrevocable offers of dedication; and

WHEREAS, on June 24, 2003, the City Council of the City of Riverside adopted Resolution No. 20458; and

WHEREAS, Resolution No. 20458 deleted the classification for Real Property Services Manager; and

WHEREAS, authority needs to be given in place of the Real Property Services Manager to allow for the continued smooth acceptance of real property interests and consent to the recordation of irrevocable offers of dedication.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Riverside as follows:

Section 1: That from and after the date of adoption of this Resolution, all deeds and/or grants conveying to the City of Riverside ("City") for public purposes any interest in or easement upon real property may be accepted for and on behalf of the City by its Assistant City Manager, General Services Director or General Services Administrative Services Manager, and that the written acceptance of such deeds or grants by the Assistant City Manager, General Services Director or General Services Administrative Services Manager on behalf of the City shall also constitute the consent of the City to



1 the recordation of such instruments.

2 Section 2: That from and after the date of adoption of this Resolution the recordation of all
3 irrevocable offers of dedication to the City of real property for any public purpose, including but not
4 limited to, streets, highways, paths, alleys, including access rights and abutters' rights, drainage, open
5 space, public utility or other public easements, parks, or other public places, may be consented to on
6 behalf of the City by its Assistant City Manager, General Services Director or General Services
7 Administrative Services Manager.

8 Section 3: The City Clerk of the City, upon adoption of this Resolution, is hereby authorized
9 and directed to transmit to the County Recorder of Riverside County, a certified copy of this Resolution
10 for recordation in the office of said County Recorder.

11 Section 4: Resolution No. 18233 is hereby repealed in its entirety.


