

Project: La Sierra Ave Street Improvements

That portion of Lot 6, in Block 12 of the Resubdivision of the Lands of J.F. Moulton and H.B. Praed, in the City of Riverside, County of Riverside, State of California, as shown by map filed in Map Book 1, Pages 49 and 50, in the Office of the County Recorder of said County, more particularly described as follows:

BEGINNING at the most westerly corner of said Lot 6, said point being on a line that is parallel with, and 30.00 feet southeasterly, measured at right angles, from the centerline of Victoria Avenue, as shown by Parcel Map No. 9026, filed in Parcel Map Book 60, Page 15, in said Office of the County Recorder;

Thence North 56°02'31" East along said parallel line, a distance of 47.51 feet;

Thence South 10°55'33" West leaving said parallel line, a distance of 24.95 feet to a point on a line that is parallel with, and 55.00 feet northeasterly, measured at right angles, from the centerline of La Sierra Avenue, as shown on said Parcel Map No. 9026;

Thence South 33°38'35" East along said parallel line, a distance of 684.86 feet to a point on the southeasterly line of said Lot 6;

Thence South 56°02'31" West along said southeasterly line, a distance of 30.00 feet to the most southerly corner of said Lot 6, said point being on a line that is parallel with, and 25.00 feet northeasterly, measured at right angles, from the centerline of La Sierra Avenue, as shown on said Parcel Map No. 9026;


Thence North 33°38'35" West along said parallel line, a distance of 702.54 feet to the **POINT OF BEGINNING.**
