GRANT OF EASEMENT







Right of Way Dedication

SIERRA RIDGE DRIVE

Those portions of Parcels 18, 19, 20, 21, 22, 23 and 85 of Parcel Map No. 24535, on file in Book 162 of Parcel Maps, Pages 84 through 90 inclusive, Records of Riverside County, California, being a portion of Section 4, Township 3 South, Range 4 West, San Bernardino Meridian, said portions being more particularly described as follows:

COMMENCING at the Southeast Corner of the Southwest Quarter of the Northeast Quarter of the Southeast Quarter of said Section 4 as shown on said Parcel Map 24535;

Thence S 89°28'31" W along the Southerly Sixteenth line, a distance of 28.99 feet to the Westerly right-of-way line of Sycamore Canyon Boulevard and to the **Point of Beginning**;

Thence continuing S 89°28'31" W along said Southerly Sixteenth line, a distance of 1311.66 feet to the Southwest corner of the Southeast Quarter of the Northwest Quarter of the Southeast Quarter of said Section 4 and to a point of intersection of the Southerly prolongation of the Westerly line of said Parcel 23;

Thence N 00°14'56" W along said Southerly prolongation of the Westerly line of Parcel 23, a distance of 37.00 feet to a line lying parallel to and 37.00 feet Northerly of said Southerly Sixteenth line;

Thence N 89°28'31" E along said parallel line 903.15 feet to a tangent curve, radius 1775.00 feet and concave Northerly, said curve being parallel to and 17 feet Southerly of the Southerly line of Remainder Parcel "B" being a portion of Parcel Map 31139-1 said County of Riverside Records;

Thence along said curve 286.89 feet and through a central angle of 09°15'38";

Thence N 80°12'53" E a distance of 86.15 feet along a line parallel to and 17 feet Southerly of the Southerly line of said Remainder Parcel "B";

Thence N 35°14'42" E a distance of 35.45 feet to the westerly right-of-way line of Sycamore Canyon Boulevard and a non tangent curve with a radial bearing N 82°56'33" E, radius 1053.00 feet, concave Easterly;


Thence Southerly 104.19 feet along said right-of-way and said curve through a central angle of 05°40'09" to the **Point of Beginning**.
