

Grant Deed

That certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 78 of Division "C" of Hall's Addition to Riverside, as shown by map on file in Book 9, Page 3 of Maps, records of San Bernardino County, California, together with that portion of the northerly one-half of that certain unnamed street, known as Willow Avenue, as shown by said map and vacated by Resolution No. 265 of the Common Council of the City of Riverside on April 17, 1913, a certified copy of said Resolution No. 265 recorded June 27, 2013, per Document No. 2013-0308084 of Official Records of Riverside County, California, more particularly described as follows:

BEGINNING at the most northerly corner of said Lot 78;

THENCE southeasterly along the northeasterly line of said Lot 78, a distance of 65.00 feet;

THENCE southwesterly along a line parallel with the northwesterly line of said Lot 78 to the southerly line of said northerly one-half of said vacated street;

THENCE westerly along said southerly line to the southwesterly prolongation of said northwesterly line of Lot 78;

THENCE northeasterly along said southwesterly prolongation of the northwesterly line of Lot 78 and along said northwesterly line of Lot 78 to the POINT OF BEGINNING.


