7 WHEREAS, the City of Riverside proposes to vacate an approximately 371 foot long by  
8 15 foot wide portion of an unimproved alley located adjacent to 2848 Main Street, in the City of  
9 Riverside, California, as described and depicted in Exhibit "A", attached hereto and incorporated  
10 by reference ("Property"); and

11 WHEREAS, the Property is excess right-of-way and is no longer required for street or  
12 highway purposes; and

13 WHEREAS, the adjoining properties and public service easements will not be affected by  
14 the vacation of the Property; and

15 WHEREAS, Section 8334 of the Streets and Highways Code provides that the legislative  
16 body of a local agency may summarily vacate the excess right-of-way of a street or highway not  
17 required for street or highway purposes; and

18 WHEREAS, the City Council wishes to proceed under the provisions of Section 8330, et  
19 seq. of the Street and Highways Code to summarily vacate the Property.

20 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,

22 Section 1: The vacation of the Property is undertaken pursuant to the provisions of  
23 Chapter 4 (commencing with Section 8330) of Part 3 of the Streets and Highways Code of the  
24 State of California.


Section 3: The proposed summary street vacation project is exempt from the provisions of the California Environmental Quality Act pursuant to Section 15061 (b) (3) of the Guidelines for Implementation of the California Environmental Quality Act (Title 15, California Code of Regulations, commencing with Section 15000) as it can be seen with certainty that there is no possibility that the activity will have a significant effect on the environment.

Section 4: The City Council hereby orders the Summary Vacation of an approximately 371 foot long by 15 foot wide portion of an unimproved alley located adjacent to 2848 Main Street, in the City of Riverside, California, as particularly described and depicted in Exhibit "A", attached hereto and incorporated herein by this reference, subject to the Recommended Conditions contained in the Council Report, and further, reserving and excepting in place easements and rights-of-way, if the same exist, from the vacation herein above ordered: an easement for, and right to construct, maintain, operate, inspect, replace, remove, renew, repair and enlarge lines of pipe, conduits, cables, wires, poles, vaults, manholes, markers, equipment, fixtures and other convenient and appurtenant structures, for the distribution and/or transmission of electrical energy, water pipelines, gas lines, storm drains, sanitary sewers, telephone, telegraph, cable television and other communication facilities, as may from time to time be required.

Section 5: The City Clerk of the City of Riverside shall assign a deed number hereto and cause a certified copy of this resolution to be recorded in the Office of the County Recorder of Riverside County, California, of the public street described and depicted in Exhibit "A" shall be and is hereby terminated as of the date of said recordation and shall no longer constitute a public street or right-of-way from and after said date of recordation.







2 property and will not affect any public service easement.

3 (c) The portions of the streets have been closed and impassable as a public  
4 road and no public funds have been expended on its maintenance for the last give year.


5 Section 3: The proposed summary street vacation project is exempt from the provisions  
6 of the California Environmental Quality Act pursuant to Section 15061 (b) (3) of the Guidelines  
7 for Implementation of the California Environmental Quality Act (Title 15, California Code of  
8 Regulations, commencing with Section 15000) as it can be seen with certainty that there is no  
9 possibility that the activity will have a significant effect on the environment.

10 Section 4: The City Council hereby orders the Summary Vacation of an approximately  
11 371 foot long by 15 foot wide portion of an unimproved alley located adjacent to 2848 Main  
12 Street, in the City of Riverside, California, as particularly described and depicted in Exhibit "A",

19 of electrical energy, water pipelines, gas lines, storm drains, sanitary sewers, telephone,  
20 telegraph, cable television and other communication facilities, as may from time to time be  
21 required.

22 Section 5: The City Clerk of the City of Riverside shall assign a deed number hereto and  
23 cause a certified copy of this resolution to be recorded in the Office of the County Recorder of  
24 Riverside County, California, of the public street described and depicted in Exhibit "A" shall be  
25 and is hereby terminated as of the date of said recordation and shall no longer constitute a public  
26 street or right-of-way from and after said date of recordation.


