A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING EASEMENTS AND RIGHTS OF WAY OVER AND ACROSS AN ALLEY AND A PORTION OF AN ALLEY IN THE DAVIS SUBDIVISION.

WHEREAS, it appears that the City has permanent easements and rights of way over and across an alley and a portion of an alley in the Davis Subdivision; and,

WHEREAS, it appears that said easements and rights of way are no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easements and rights of way be and the same are hereby vacated. The said easements and rights of way are situate in the City of Riverside, County of Riverside, State of California, and are described as follows:

Permanent easements and rights of way to construct, maintain, operate, replace, remove and renew sanitary sewers and storm drains and appurtenant structures, and reserving the right to construct, maintain, operate, replace, remove, renew and enlarge lines of pipe, conduits, cables, wires, poles and other convenient structures, equipment and fixtures for the operation of gas pipe lines, telegraphic and telephone lines and for the transportation and distribution of electric energy, petroleum and its products, water and incidental purposes, including access, and the right to keep the property free from inflammable materials and wood growth and otherwise protect the same from all hazards in, upon and over the following described property:

(a) All that certain alley lying between Lot 18 and Lots 12, 13, 14, 15, 16 and 17 as shown on Map of Davis Subdivision of Block 8, Range 6 of the Town of Riverside on file in Book 1, page 65 of Maps, Records of San Bernardino County, California; and

(b) That portion of that certain alley lying between Lot 19 and Lot 25, as shown on map of Davis Subdivision of Block 8, Range 6 of the Town of Riverside on file in Book 1, page 65 of Maps, Records of San Bernardino County, California, described as follows:

Beginning at the most northerly corner of said Lot 19;

Thence northwesterly along the prolongation of the northeasterly line of said Lot 19 to an intersection with the northeasterly prolongation of the northwesterly line of said Lot 19;

Thence southwesterly along said northeasterly prolongation to the northwesterly corner of said Lot 19;

Thence northeasterly on a direct line to the point of beginning.

1 IT IS FURTHER ORDERED that the City Clerk of said City  
2 of Riverside shall cause a certified copy of this resolution  
3 and order, attested by the City Clerk under the seal of said City  
4 to be recorded in the office of the County Recorder of Riverside  
5 County, California.
