

RESOLUTION NO. 9252

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF A PORTION OF LOT 54 OF LANDS OF THE EAST RIVERSIDE LAND COMPANY TO THE PUBLIC USE FOR ALLEY PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside;

That the herein described strip or parcel of land is hereby accepted by the City of Riverside to the public use for alley purposes.

Said strip or parcel of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

A strip of land 20.0 feet in width being the southerly 20.0 feet of Lot 54 of the Lands of the East Riverside Land Company in a part of the Southwest quarter of Section 19, Township 2 South, Range 4 West, San Bernardino Base and Meridian, as shown on map on file in Book 6, page 44 of Maps, Records of San Bernardino County, California;

EXCEPTING the westerly 33.0 feet in Cranford Avenue.

The City Clerk is authorized and directed to cause a copy of this resolution to be recorded by the County Recorder of Riverside County.
