Grant Deed

DALE A. WILLIAMS and FRANCES R. WILLIAMS

Grant to the County of Riverside all that real property in Riverside County, California, described as follows:

The lots and portion of lots shown on Map of Camp Ansa Subdivision No. 1, filed in Book 22, page 61 and 62 of Maps, records of Riverside County, more particularly described as follows:

1. All of Lot 151.
2. All of Lot 182.
3. A portion of Lot 162, described as follows:
Beginning at the southwest corner of said Lot 162;
Thence northerly along the westerly line of said Lot 162 a distance of 20 feet;
Thence southeasterly, along the arc of a 20 foot radius curve, concave to the northeast, through an angle of 90°, for an arc distance of 31.42 feet to a point on the southerly line of said Lot 162;
Thence westerly along said southerly line of Lot 162, a distance of 20 feet to the point of beginning.
4. A portion of Lot 160, described as follows:
Beginning at the southeast corner of said Lot 160;
Thence westerly along the southerly line of said Lot 160, a distance of 20 feet;
Thence northeasterly, along the arc of a 20 foot radius curve, concave to the northwest, through an angle of 90°, for an arc distance of 31.42 feet to a point on the easterly line of said Lot 160;
Thence southerly along said easterly line of Lot 160, a distance of 20 feet to the point of beginning.
5. A portion of Lot 183, described as follows:
Beginning at the northeast corner of said Lot 183;
Thence southerly along the easterly line of said Lot 183, a distance of 20 feet;
Thence northwesterly, along the arc of a 20 foot radius curve, concave to the southwest, through an angle of 90°, for an arc distance of 31.42 feet to a point on the northerly line of said Lot 183;
Thence easterly along said northerly line of Lot 183, a distance of 20 feet to the point of beginning.
