

RESOLUTION NO. 9458

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS, the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the hereinafter designated streets be changed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

HANTON STREET

All of that certain street known as Hanton Street, of variable width, as said street now exists within Mc Claskey Tract, said tract being shown on map on file in Book 10, pages 36 and 37 of Maps, records of Riverside County, California; the westerly terminus of said street being the easterly line of Doolittle Avenue (formerly Pedley Road) as shown on said map and the easterly terminus of said street being the easterly boundary of said Mc Claskey Tract,

be changed to CENTRAL AVENUE.

BOND STREET

All of that certain street of variable width now known as Bond Street (formerly Durando Drive) being all of Lot "B" of University Highlands No.4 Unit No.1 as shown on map on file in Book 40, pages 31 through 33, inclusive, of Maps, Records of Riverside County California, and all of Lot "B" of Town and Country Estates No.5, Unit No.1, as shown on map on file in Book 39, pages 77 and 78 of Maps, Records of said County,

be changed to CELESTE DRIVE.
