

SLOPE EASEMENT

THIS INSTRUMENT, made this 18th day of DEC

in the year of our Lord, Nineteen Hundred and Sixty-one, between C. HOWARD GOEPPINGER, a married man; ALBERT L. GOEPPINGER, a married man; EDWARD J. GOEPPINGER, a married man, as their separate property, parties of the first part, and the CITY OF RIVERSIDE, a municipal corporation of the State of California, the party of the second part:

WITNESSETH: That the said parties of the first part, for a valuable consideration, do by these presents grant unto the party of the second part, a perpetual easement and right-of-way for roadway slope purposes, over and along that certain parcel of land in the City of Riverside, County of Riverside, State of California, described as:

A strip of land of variable width in a part of Lot 4 of Rancharia de Pachappa as shown on map on file in Book 2, page 38 of Maps, Records of Riverside County, California, described as follows:

Commencing at the northwesterly corner of said Lot 4, which point is also the intersection of the Union Pacific Railway Company right-of-way and the southerly line of Panorama Road, 30.0 feet in width;

Thence South 57° 59' 10" West along the southeasterly line of said Railway right-of-way, a distance of 25.93 feet to a point on a line that is parallel with and 20.0 feet southerly from the southerly line of said Panorama Road;

Thence South 71° 33' 13" East along said parallel line, a distance of 156.55 feet to a point;

Thence at a right angle to said parallel line, South 18° 26' 47" West, a distance of 2.25 feet;

Thence North 72° 59' 12" West, a distance of 50.02 feet;

Thence North 74° 24' 57" West, a distance of 50.06 feet;

Thence North 73° 16' 23" West, a distance of 63.10 feet to the southeasterly line of said Union Pacific Railway Company right-of-way;

Thence North 57° 59' 10" East along said southeasterly right-of-way line, a distance of 10.24 feet to the TRUE point of beginning.


