DEPT OF PUBLIC WORKS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF HOWE AVENUE TO CORNWALL AVENUE.



WHEREAS, the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the name of the herein-after designated portion of Howe Avenue be changed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the following described portion of HOWE AVENUE

All that portion of that certain street now known as Howe Avenue (formerly Lawrence Avenue) 40 feet in width, as shown on map of the Church Subdivision, on file in Book 6, page 55 of Maps, Records of Riverside County, California, which extends northeasterly and easterly from the following described line:

Commencing at a point in the southerly line of Lot D (Howe Avenue) as shown on map of Fairview Estates No.5 on file in Book 41, pages 98, 99 and 100 of Maps, Records of Riverside County, California, said point being the northeasterly corner of Lot 103 of said Fairview Estates No.5;

Thence North 01° 27' West, 66 feet (at right angles to said southerly line of Lot D) to the true point of beginning;

Thence North 88° 33' East parallel with said southerly line of Lot D to a point in the southeasterly line of said Howe Avenue, 40 feet in width, and the end of this line description,

be changed to CORNWALL AVENUE.
