RESOLUTION NO. 9927

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT IN A PORTION OF LOTS 1 AND 2 OF ARLINGTON AVENUE TRACT.

WHEREAS, it appears that the City of Riverside has a public utility easement in a portion of Lots 1 and 2 of Arlington Avenue Tract; and

WHEREAS, it appears that said public utility easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utility easement be and the same is hereby vacated. That said easement is situate in the City of Riverside, County of Riverside, State of California, and described as follows:

An easement for public utilities over the rear 10 feet of Lots 1 and 2 of Arlington Avenue Tract, as shown on Map in Book 24, page 67 of Maps, Riverside County Records.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.


