WITNESSETH;

That for a valuable consideration, receipt whereof is hereby acknowledged, said party of the first part does by these presents grant unto the said party of the second part, its successors and assigns, a perpetual easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement and removal of a Domestic Water System and necessary appurtenances, in, under and along that certain parcel of land, situated in the County of Riverside, State of California, described as follows:

See attached description:

An easement 20.00 feet in width for the construction and maintenance of a water line over a portion of Lot 8 of Monte Vista Tract, as shown by map on file in Map Book 6 at Page 20 thereof, Records of Riverside County, California, the center line of said easement being described as follows:
Beginning at a point on the Ely line of Lot A of Tract 2604, as shown by map on file in Map Book 48 at Page 5 thereof, Records of Riverside County, California, which bears N 14° 28' 00" E, a distance of 31.11 feet from the most Nly corner of Lot 12 of said Tract 2604;
the second course (N 25° 11' 00" E, a distance of 44.50 feet;
thence Ely on a curve concave to the South having a radius of 208.00 feet through an angle of 161° 10' 27", an arc length of 131.81 feet to the end of said easement, said line being the center line of private road as shown on said map of Monte Vista Tract, and the Ely line of said easement being shortened or lengthened as necessary at the Ely line of said Lot A and the center line of said private road.
