A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

BRIAN WAY described as:

All that certain street known as Brian Way lying between Vasquez Place and Bunche Place, as shown on map of Nesgren Tract on file in Book 40, pages 1 and 2 of Maps, Records of Riverside County, California,

be changed to LANGSTON PLACE.

HARRIS STREET described as:

All of that certain street known as Harris Street lying between Norwood Avenue and La Verne Drive as said street is shown on the following maps recorded in the office of the County Recorder of Riverside County, California:

- Myerscough Subdivision Unit 1, Book 41, pages 17 and 18 of Maps
- Myerscough Subdivision Unit 2, Book 42, page 37 of Maps,
- Norwood Manor Unit 1, Book 24, page 15 of Maps
- Norwood Manor Unit 2, Book 25, pages 64 and 65 of Maps,

be changed to CAROB WAY.


