RESOLUTION

WHEREAS, pursuant to Section 559 of the Streets and Highways Code, a public hearing after due notice has been held upon a resolution of intention to abandon as unnecessary the following described highways in the First Road District, County of Riverside, State of California:

X1. Lot G and Lot GG, designated as Inaslack Avenue, as shown on Map of La Sierra Gardens, filed in Map Book 11, Pages 42 to 50, Records of Riverside County, excepting therefrom Parcel 1060-9 as shown on Record of Survey filed in Book 34, pages 3 to 6, inclusive, Records of Riverside County, and excepting therefrom any portion within the right of way of State Highway Route 43-B as shown on right of way map dated July 16, 1957.

X2. Lot SS, designated as Truschell Avenue, as shown on said map of La Sierra Gardens, excepting therefrom Parcel 1060-11 as shown on said Record of Survey.

X3. Lot CH, designated as Lyon Avenue, excepting therefrom that portion lying southeasterly of the northerly westerly prolongation of the northerly line of Lot 7, 6-36-14-DIEN-22, as shown on said map of La Sierra Gardens.

X4. Lot CI, designated as Schofield Avenue, as shown on said map of La Sierra Gardens, excepting therefrom Parcel 1060-16 as shown on Record of Survey filed in Book 35, pages 16 to 18, inclusive, Records of Riverside County.

X5. Lot RH, designated as Miller Avenue, as shown on said map of La Sierra Gardens, excepting therefrom Parcel 1060-10 as shown on Record of Survey filed in Book 35, pages 16 to 18 inclusive, Records of Riverside County.

X6. Lot CC, designated as Hedrick Avenue, excepting therefrom that portion lying southeasterly of the following described line: Beginning at the intersection of the southeasterly line of Lot S, designated as Hole Avenue, and the center line of Lot CH, designated as Jones Avenue. Thence S. 57° 51' 45" W., a distance of 179.36 feet to the southeasterly line of said Lot C, as shown on said map of La Sierra Gardens.

Lot G and Lot GG, designated as Kaselack Avenue, as shown on Map of La Sierra Gardens, filed in Map Book 11, Pages 42 to 50, Records of Riverside County, excepting therefrom Parcel 1060-9 as shown on Record of Survey filed in Book 34, pages 3 to 6, inclusive, Records of Riverside County, and excepting therefrom any portion within the right of way of State Highway Route 43-B as shown on right of way map dated July 16, 1957.

2. Lot SS, designated as Truschell Avenue, as shown on said Map of La Sierra Gardens, excepting therefrom Parcel 1060-11 as shown on said Record of Survey.

3. Lot CK, designated as Lyon Avenue, excepting therefrom that portion lying southeasterly of the northeasterly prolongation of the northwesterly line of Lot 7, Block 22, as shown on said Map of La Sierra Gardens.

4. Lot CI, designated as Skofstad Avenue, as shown on said Map of La Sierra Gardens, excepting therefrom Parcel 1060-16 as shown on Record of Survey filed in Book 35, pages 16 to 18, inclusive, Records of Riverside County.

5. Lot RR, designated as Miller Avenue, as shown on said Map of La Sierra Gardens, excepting therefrom Parcel 1060-18 as shown on Record of Survey filed in Book 35, pages 16 to 18 inclusive, Records of Riverside County.

6. Lot Ca, designated as Hedrick Avenue, excepting therefrom that portion lying southeasterly of the following described line:

Beginning at the intersection of the southwesterly line of Lot S, designated as Hole Avenue, and the center line of Lot CH, designated as Jones Avenue.

Thence S. 57° 54' 45" W., a distance of 479.36 feet to the southwesterly line of said Lot Ca, as shown on said Map of La Sierra Gardens.
