GRANT OF EASEMENT

THE GRANTORS, RUTH G. FULLER, a widow, RAYMOND W. FULLER and EVELYN FULLER, Husband and Wife, CHARLES J. THOMAS and RITA S. THOMAS, Husband and Wife, hereby grant to SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, its successors and assigns, an easement and right of way to construct, use, maintain, alter, add to, repair, replace and/or remove, in, on, and over the real property hereinafter described, situated in the County of Riverside, State of California, an electric line, consisting of ~~poles, necessary~~ ~~poles and anchors~~, cross-arms, wires and other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone and/or other purposes.

Said real property is described as follows:

The westerly 6 feet of Lot 5, Block 20, LA GRANADA, as per map recorded in Book 12, pages 42 to 51 inclusive of Maps, in the office of the Recorder of said County.
