# RIGHT OF WAY

6137

Inglewood, California, June 24, 1927.

For and in consideration of the sum of One Dollar (\$1.00), receipt whereof is hereby acknowledged, a right of way is hereby granted to THE SOUTHERN SIERRAS POWER COMPANY, its successors and assigns, with the right to erect and maintain poles or other supports, with wires and fixtures thereon necessary for the purposes of said Power Company, and to clear, grade and keep same free from brush and wood growth to such a width as may be necessary for protection from fire, across that certain

property belonging to Oscar W. Crocker and A. Louise Crocker, his wife,

situated in the County of Riverside, State of California, said property being described as follows:

Lot Five (5) in Block Fifty-four (54) of "La Sierra Gardens", according to a map recorded in Map Book Eleven (11) at Page Forty-six (46), Records of Riverside County.

The center line of said right of way is described as follows.

Beginning at a point on the North boundary line and One (1) foot West of the Northeast corner of said Lot Five (5) as an initial point, running thence Southeasterly parallel with and One (1) foot West of the Easterly boundary line of said Lot (said boundary line being common to the Westerly boundary line of Polk Street) a distance of Four Hundred Seventy (470) feet more or less to a point on the Southerly boundary line of said Lot.

It is understood that the employes of said Power Company, with their equipment, shall whenever necessary, have the right of access, transportation, and travel to and along said right of way and the supports and wires thereon, for purposes of inspections, renewals, repairs, additions, etc., provided always that the said Power Company shall be responsible for any damages which may be unnecessarily done to the property above described.
