RESOLUTION NO. 11167

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF CARLO DRIVE.

WHEREAS on November 19, 1968, the City Council of the City of Riverside adopted Resolution No. 11135 declaring its intention to order the vacation of a portion of Carlo Drive and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found, and hereby finds from all of the evidence submitted that the portion of Carlo Drive hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that said portion of Carlo Drive in the City of Riverside, County of Riverside, State of California, described as follows:

Those portions of Sections 28 and 33, Township 2 South, Range 5 West, as shown by map showing subdivisions of Section 33 and Fractional Section 28, Township 2 South, Range 5 West, San Bernardino Meridian, recorded in Book 2, page 2 of Maps, San Bernardino County records described as follows:

Commencing at a point on the center line of Jurupa Avenue 10.425 chains westerly from the intersection with the easterly line of Lot 2 in said Section 28 with the center line of said Jurupa Avenue;

Thence South 0° 14' East 33.08 feet to the southerly line of said Jurupa Avenue;

Thence North 86° 14' West, along said southerly line, 644.40 feet;

Thence South 0° 14' East 11.03 feet to the true point of beginning;

Thence continuing South 0° 14' East 792.04 feet;

Thence North 89° 25' 30" East 33.00 feet;

Thence North 0° 14' West 789.54 feet to a point which is a perpendicular distance of 44.00 feet from the center line of said Jurupa Avenue;

Thence North 86° 14' West 33.08 feet to the true point of beginning;




