RESOLUTION NO. 11407

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING ALLEYS BETWEEN COLUMBUS AVENUE AND REPUBLIC STREET AND BETWEEN REPUBLIC STREET AND ORDWAY STREET.

WHEREAS on November 18, 1969, the City Council of the City of Riverside adopted Resolution No. 11389 declaring its intention to order the vacation of alleys between Columbus Avenue and Republic Street and between Republic Street and Ordway Street and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that said alleys hereinafter ordered vacated are unnecessary for present or prospective public use;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the alleys in the City of Riverside, County of Riverside, State of California; described as follows:

PARCEL 1:

That certain alley 15 feet in width adjoining Lots 7 through 16, inclusive; Lots 17 through 22, inclusive; Lots 23 through 31, inclusive, and Lots 3 through 6, inclusive, in Block 17 of Tract No. 3 of Riverview Addition to the City of Riverside, as shown by map on file in Book 7, page 5 of Maps, records of Riverside County, California;

EXCEPTING THEREFROM the west 8 feet as measured at right angles west to a line that is

 11 view Addition to the City of Riverside as shown by
 12 map on file in Book 7, page 5 of Maps, records of
 13 Riverside County, California;

14 EXCEPTING THEREFROM the west 8 feet as measured
 15 at right angles west to a line that is parallel with
 16 and distant 33 feet east of the center line of
 17 Republic Street, as said street is shown on said
 18 Tract No.3,


