A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF OLIVEWOOD AVENUE TO PACHAPPA DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside that the name of a portion of Olivewood Avenue described as follows:

All that certain public street known as Olivewood Avenue lying southerly of Jurupa Avenue and easterly of Sunnyside Drive and shown by map of Pachappa Heights Addition No.3 on file in Book 25, page 34 of Maps, by map of Pachappa Hill Groves on file in Book 4, page 46 of Records of Survey and by Sheet No.2 of State Relinquish Map VIII-Riv-43-Riv-1-7, recorded on December 16, 1957, in Book 2, pages 120 through 126, inclusive, of State Highway Maps, Records of Riverside County, California,

be changed to PACHAPPA DRIVE.


