RESOLUTION

1 WHEREAS, pursuant to Section 959 of the Streets and
2 Highways Code, a public hearing after due notice has been held upon
3 a resolution of intention to abandon portions of Cottonwood Avenue
4 and Cole Street in the Woodcrest area, in the Fifth Supervisorial
5 District, and all persons having had an opportunity to be heard,
6 now, therefore,

8 BE IT RESOLVED by the Board of Supervisors of the County
9 of Riverside, State of California in regular session assembled on
10 October 7, 1968, that the following portions of County Highways
11 in the Woodcrest area, Fifth Supervisorial District are hereby
12 vacated and abandoned:

Cottonwood Avenue

13 The southerly one-half of that certain unnamed
14 street 60 feet in width, now known as Cottonwood
15 Avenue, adjoining the northerly line of Lot 3 in
16 Block 5 in Section 8, T. 3S., R. 4W., S.B.M., as
17 shown on Map of the Alessandro Tract on file in
18 Book 6, page 13, of Maps, Records of San Bernardino
19 County, California;

20 EXCEPTING that portion lying within the easterly
21 50 feet of said Section 8.

22 RESERVING an easement therein for any existing
23 public utilities or public service facilities.

Cole Street

24 All that certain unnamed street 60 feet in width,
25 now known as Cole Street, lying between Lots 3
26 and 4 in Block 4 and Lots 1 and 2 in Block 5, all
27 in Section 8, T. 3 S., R. 4W., S.B.M., as shown
28 on Map of the Alessandro Tract on file in Book 6,
29 page 13, of Maps, Records of San Bernardino
30 County, California;

31 EXCEPTING that portion lying northerly of the
32 southerly line of Cottonwood Avenue, 60 feet wide
33 and EXCEPTING that portion lying within the
34 southerly 40 feet of said Section 8.

35 RESERVING an easement therein for any existing
36 public utilities or public service facilities.

37 BE IT FURTHER RESOLVED that a copy of this resolution be
38 filed with the Recorder of Riverside County.
