RESOLUTION

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled this 20th day of October, 1958, that the following described portion of a county road, having been superseded by relocation, is hereby summarily abandoned, the same being described as follows:

In the County of Riverside, State of California, described as that portion of Section 15, T. 3 S., R. 6 W., S. B. B. & M., as shown by map of Rancho La Sierra, on file in Book 6, page 70 of Maps, Records of Riverside County, more particularly described as follows:

PARCEL 1:

The easterly rectangular 20 feet of Parcel 2, of that certain parcel of land conveyed to the County of Riverside by deed recorded April 1, 1952, in Book 1355, page 542, Records of Riverside County, lying westerly of the westerly line of Parcel 3 (88 feet in width) of that certain parcel of land conveyed to said Riverside County by deed recorded December 6, 1956 in Book 2008, page 354, Records of Riverside County.

Excepting therefrom that portion described by metes and bounds as follows:

Beginning at the intersection of the easterly line of Parcel 2, 40 feet in width with the westerly line of Parcel 3, 88 feet in width; thence S.24°26'36"E., along said westerly line a distance of 34.07 feet to a point which is 20 feet in right angle distance westerly from said easterly line; thence parallel with said easterly line, along the arc of a 793.57 foot radius curve, concave southwesterly, through an angle of 1°02'45", for an arc distance of 14.49 feet, to the end thereof; thence continuing parallel with said easterly line, N.60°38'15"W., a distance of 27.17 feet; thence along the arc of a tangent curve, concave northerly, having a radius of 15, through an angle of 109°28'10", for an arc distance of 28.36 feet to the point of beginning.

PARCEL 2:

Beginning at the southeasterly corner of Parcel 3 of that certain parcel of land conveyed to the county of Riverside by said deed recorded April 1, 1952, in Book 1355, page 542; thence N.0°23'W. along the easterly line of said Parcel 3, a distance of 94.78 feet; thence northerly on said easterly line, along the arc of a

Reserving and excepting the easement and right of way therein for existing and future public utility, public service and drainage facilities and structures pursuant to Section 959.1 of the Streets and Highway Code.
