A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, VACATING A PUBLIC UTILITIES EASEMENT IN LOT 18 OF BLOCK 32 OF THE RESUBDIVISION OF BLOCK 32 OF ARLINGTON HEIGHTS WHICH HAS BEEN SUPERSEDED BY RELOCATION, DIVISION 2.5 OF THE STREETS AND HIGHWAYS CODE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the Public Utilities easement described as:

A public utilities easement, 12.00 feet in width, the centerline of said easement being described as follows:


Beginning at a point on the southwesterly line of Lot 18 of the resubdivision of Block 32 of Arlington Heights as shown by map on file in Book 1, Page 37 of Maps, records of Riverside County, California, which bears South 34° 01' 40" East, a distance of 286.96 feet from the most westerly corner of said Lot 18;

Thence North 56° 00' 50" East, a distance of 641.28 feet to the southwesterly line of Gratton Street (80.00 feet wide) and the END of this centerline description.


be and is hereby vacated, said easement having been superseded by relocation.
