RESOLUTION NO. 11687

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT OVER A PORTION OF LOT 444 OF SIERRA FOOTHILLS TRACT UNIT NO. 8, AS SHOWN BY MAP ON FILE IN BOOK 36 OF MAPS, AT PAGES 12 AND 13 THEREOF, RECORDS OF RIVERSIDE COUNTY, CALIFORNIA.

WHEREAS it appears that the City of Riverside has a public utility easement over a portion of Lot 444 of Sierra Foothills Tract Unit No. 8, as shown by map on file in Book 36 of Maps, at pages 12 and 13 thereof, records of Riverside County, California; and

WHEREAS it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utility easement be and the same is hereby vacated, said easement being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

The south 6.00 feet of Lot 444 of Sierra Foothills Tract Unit No. 8, as shown by map on file in Book 36 of Maps, at pages 12 and 13 thereof, Records of Riverside County, California; said 6.00 feet being measured at right angles 6.00 feet north from the south line of said Lot 444;

EXCEPTING therefrom the northeast 6.00 feet as measured at right angles southwest from the northeast line of said Lot 444.

IT IS FURTHER ORDERED that the City Clerk of the City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.


