A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, PROVIDING FOR SUMMARY VACATION AND ABANDONMENT OF A PORTION OF THIRD STREET AT THE NORTHEASTERLY CORNER OF FAIRMOUNT BOULEVARD AND THIRD STREET, AND MAKING ITS ORDER VACATING SAID PORTION OF THIRD STREET.

WHEREAS Sections 1930 et seq. of the Streets and Highways Code of the State of California provide for summary vacation and abandonment of streets under certain conditions; and

WHEREAS the City Council finds and determines that the vacation of the hereinafter described portion of Third Street will not cut off all access to property of any person; and

WHEREAS the Circulation Element of the General Plan has been amended to reduce the width of Third Street to a 66-foot-wide local street; and

WHEREAS as a result of said General Plan amendment portions of said Third Street have been superseded by the relocation of the right-of-way width;

NOW, THEREFORE, the City Council of the City of Riverside hereby determines and orders that the following described portion of Third Street is hereby summarily vacated:

A strip of land 11.0 feet in width, being the southwesterly 11.0 feet of Lot 7 of C. H. Greenshaw's Resubdivision of Block 2, Range 8 of the Town of Riverside, as shown on map on file in Book 5, page 156 of Maps, Records of Riverside County, California.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested by the City Clerk under the seal of said City, to be recorded in the Office of the County Recorder of Riverside County, California.


