A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITIES EASEMENT OVER PORTIONS OF LOTS 21 THROUGH 32, INCLUSIVE, OF TRACT NO. 3026.

WHEREAS it appears that the City of Riverside has a public utilities easement over portions of Tract No. 3026; and

WHEREAS it appears that said easement is no longer necessary for present or prospective use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utilities easement be and the same is hereby vacated, said easement being situated in the City of Riverside, County of Riverside, State of California, and described as follows:

The easterly 15.00 feet of Lots 21 thru 32, inclusive, of TRACT No. 3026, as shown by map on file in Book 57 of Maps, at pages 14 and 15 thereof, records of Riverside County, California; also said easterly 15.00 feet are shown as 15' P.U.E. on said TRACT No. 3026.

EXCEPTING and RESERVING therefrom the north 16.00 feet of said Lot 32 for sanitary sewer and storm drain facilities;

ALSO EXCEPTING and RESERVING therefrom the north 12.00 feet of said Lot 32 for public utilities facilities;

ALSO EXCEPTING and RESERVING therefrom the south-east 6.00 feet of said Lot 29 for public utilities facilities;


ALSO EXCEPTING and RESERVING therefrom the north-west 6.00 feet of said Lot 28 for public utilities facilities.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
