GRANT DEED

PHILLIP W. SMITH and MILLRED A. SMITH, husband and wife, as their individual interest may appear, Grantors.

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of the northwest quarter of Section 32, Township 2 South, Range 4 West, San Bernardino Meridian, described as follows:
 Commencing at the northeast corner of that certain parcel of land conveyed to the City of Riverside, a municipal corporation, by deed recorded August 14, 1970, as Instrument No. 80235, Official Records of Riverside County, California; said corner being in a curve, concave to the west, having a radius of 2,055.00 feet; the radial line at said corner bears North 83° 46' 20" East;
 Thence North 83° 46' 20" East, 35.00 feet to a point in the east line of that certain parcel of land conveyed to the City of Riverside, a municipal corporation, by deed recorded October 23, 1970, as Instrument No. 107140, Official Records of Riverside County, California; said point being the TRUE POINT OF BEGINNING;
 Thence continuing North 83° 46' 20" East, 494.32 feet to the beginning of a tangent curve, concave southerly, having a radius of 1,000.00 feet;
 Thence easterly along said curve, an arc length of 427.60 feet through a central angle of 24° 29' 58" to the northeast corner of that certain parcel of land conveyed to Norman N.  Thence South 20° 16' 10" West, along the easterly line of said parcel recorded September 11, 1970, as Instrument No. 89426, 8.15 feet to a point in a curve, concave to the south, having a radius of 1,945.00 feet; a radial line to last mentioned point bears North 00° 35' 53" East;
 Thence westerly, along said curve, an arc length of 154.01 feet through a central angle of 4° 32' 13" to a tangent line;
