A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CORRECTING A DESCRIPTION ERROR CONTAINED IN RESOLUTION NO. 10085 OF THE CITY OF RIVERSIDE WHEREIN PORTIONS OF CERTAIN ALLEYS IN TRACT NO. 3 OF RIVERVIEW ADDITION WERE VACATED ON SEPTEMBER 22, 1964.

WHEREAS Resolution No. 10085 vacated portions of certain alleys in Tract No. 3 of Riverview Addition on September 22, 1964; and

WHEREAS it has been discovered that there was an error in the description of said resolution; and

WHEREAS it is necessary to correct this description;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the description contained in said Resolution No. 10085 is hereby amended and corrected to read as follows:

All those certain 15 feet wide alleys in Block 14 of Tract Number 3 of the Riverview Addition as shown by map on file in Book 7, page 5 of Maps, Records of Riverside County, California.

Except therefrom the southerly 13 feet of the north-south alley; and except the westerly 8 feet and the easterly 3 feet of the east-west alley.

Reserving a public utility easement in all of said east-west alley.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested by the City Clerk under the seal of said City to be recorded in the office of the County Recorder of Riverside County, California.


