FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, _____

JAY A. ANDREWS AND MARY G. ANDREWS, husband and wife,

as Grantors, grant(x) to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of _____

sanitary sewer facilities

together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the County of Riverside, State of California, described as follows:

All that portion of Lot 5 of the Bixmill Tract, as shown by map on file in Book 16 of Maps, at pages 28 to 30 inclusive thereof, Records of Riverside County, California, being a strip of land 66.00 feet in width, the centerline of which is described as follows;

Commencing at the centerline intersection of Crest Avenue and Mandalay Court, as shown by map of Tract No. 4154 recorded in Book 71 of Maps, at pages 39 and 40 thereof, Records of Riverside County, California, the centerline of said Crest Avenue has a bearing of North 00° 23' 09" East;

Thence North 89° 36' 51" West, a distance of 33.00 feet to a point in the east line of that certain parcel of land conveyed to Jay A. Andrews et ux, by deed recorded June 1, 1971 as Instrument No. 57695 of Official Records of Riverside County, California for the TRUE POINT OF BEGINNING;

Thence continuing North 89° 36' 51" West, a distance of 14.00 feet to the beginning of a tangent curve, concave to the south, having a radius of 200.00 feet;

Thence westerly along said curve, to the left, through a central angle of 27° 00' 00", an arc distance of 94.25 feet to the end thereof and the end of this centerline description.

Provided, however, that the Grantor reserves the right to use and enjoy the land over which said easement and right-of-way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right-of-way.


