of the State of California, as Grantee, its successors and assigns, a
perpetual easement and right of way for the construction, reconstruction,
maintenance, operation, inspection, repair, replacement, relocation,
renewal and removal of sanitary sewer facilities

together with all necessary appurtenances, in, under, upon, over and
along that certain real property situated in the City of Riverside,
County of Riverside, State of California, described as follows:

All that portion of Block 8 of Tract No. 3 of La Sierra Heights, as shown by
map on file in Book 8 of Maps, at page 27 thereof, Records of Riverside County,
California, more particularly described as follows:

Commencing at the most northerly corner of Lot 10 of Sharon Estates, as
shown by map on file in Book 38 of Maps, pages 1 and 2 thereof, Records of Riverside
County, California, said point also being in the southeasterly line of that certain
parcel of land conveyed to the County of Riverside by deed recorded December 12, 1956
