Grantors,

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do  
hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real  
property in the City of Riverside, County of Riverside, State of California,  
described as follows:

A strip of land 2.00 feet in width over a portion of Lot 21 of the Alamo  
Tract, as shown by map on file in Book 9 of Maps, at Page 5 thereof,  
records of said Riverside County, more particularly described as follows:

BEGINNING at a point in the northeasterly line of Strong Street distant  
175 feet southeasterly from the most westerly corner of said Lot; said  
point being also the most southerly corner of that certain parcel of land  
conveyed to Gladys Irene Hamrick by deed recorded August 15, 1960, as  
instrument No. 71645 of Official Records of said Riverside County;

THENCE northeasterly along the southeasterly line of said parcel a  
distance of 2.00 feet to a line which is parallel with and distant 27.00  
feet northeasterly, as measured at right angle, from the centerline of  
Strong Street;

THENCE southeasterly along said parallel line 105 feet to the  
northwesterly line of the southeasterly 50 feet of said Lot 21;

THENCE southwesterly along said northwesterly line of the southeasterly 50  
feet of Lot 21 a distance of 2.00 feet to said northeasterly line of  
Strong Street;

THENCE northwesterly along said northeasterly line 105 feet to the point  
of beginning.


