

Parcel B

All of Lot 2 and Lot 17 of Tract 2345 on file in map book 45 pages 85 and 86, records of Riverside County, California, together with that portion of a vacated alley adjacent to said Lots 2 and 17, lying southeasterly of the southwesterly prolongation of the northwesterly line of said Lot 2, and lying northwesterly of a line beginning at the southwest corner of said Lot 17 and extending northeasterly to the northwest corner of Lot 1 of said map.
