


RUBIDOUX HEIGHTS

in the City of Riverside, Riverside County, California, as surveyed by Kingdon & Sonburn, C.E., in November 1902, and filed in Map Book 4, at Page 40, records of Riverside County, California, showing the location of ROSE WAY through a portion of Lots 5, 6, 7, 8, 9 of Block 10, of said Rubidoux Heights, hereinafter dedicate to public use, also the divisions of a portion of 8th Street, west of Pepper Street, into a double roadway, parking space, and sidewalk spaces, to be hereinafter dedicated for public use, also a portion of 8th Street designated by a green band and marked "to be abandoned", and also the grade elevations marked in red ink figures showing grades approved by the abutting property owners
