- ④ PAINT 12" SOLID WHITE
- ⑤ PAINT "STOP" STD. PAVEMENT MARKING
- ⑥ PAINT "AHEAD" STD. PAVEMENT MARKING
- ⑦ PAINT "ARROW" MARKING (TYPE IV (L OR R))
- ⑧ PAINT 11" TWO WAY LEFT TURN (DETAIL 32)
- ⑨ INSTALL "BLUE DOT" REFLECTIVE PAVEMENT MARKER


