- B. At the rear lot corners for Lots 51 through 53; "Set 1" I.P with plastic plug stamped L.S. 3018, flush."
- C. At the easterly terminus of a course which bears N.89°34'43"E., 28.99 feet on the south line of Lot 54; "Set 1" I.P. with plastic plug stamped L.S. 3018, flush per Tract 22551 M.B. 187/62-66."


AND IS CORRECTED AS FOLLOWS:

- C. At the easterly terminus of a course which bears N.89°34'43"E., 28.99 feet on the south line of Lot 54; "Set nail and L.S. tag in top of wall pilaster for property corner."

There are no fee property owners affected by this correction.


