

RESOLUTION NO. 1562 (NEW SERIES)

Resolution Declaring that Closing up and Vacating has been completed. (A certain Alley in Santa Fe Tract)

WHEREAS the Common Council of the City of Riverside, did on the 28th day of May, 1929, pass its resolution no. 1558 (New Series) ordering the work of closing up and vacating a certain alley in Santa Fe Tract in said City hereinafter described, as contemplated by Resolution of Intention No. 1536 (New Series); and

WHEREAS, the Superintendent of Streets of said City has reported to said Common Council that the work of closing up and vacating said alley in the Sant Fe Tract in said City hereinafter described has been done and completed.

NOW THEREFORE, be it resolved that the Common Council hereby determines that that certain alley in the Santa Fe Tract in said City hereinafter described, is closed up and vacated.

That certain alley in the Santa Fe Tract in the said City described as follows, to-wit:

COMMENCING AT THE POINT OF INTERSECTION OF THE of the Center line of Howard Avenue with the Center line of East 12th Street in the City of Riverside, California; thence northerly along the center line of Howard Avenue to the north property line of East 12th Street and the south line produced Easterly of Lot 10, Block 5, Santa Fe Tract as recorded in Book 6 of Maps, page 14, Records of San Bernardino County, , California; thence Westerly along the northerly line of East 12th Street and the South line of Lots 10, 9, 8, 7, and 6 said Block 5 Santa Fe Tract to the southwest corner of said Lot 6, said point being the point of beginning of the description of the parcel of land to be abandoned; thence northerly along the west line of said Lot 6, to the northwest corner thereof; thence on a direct line across a certain alley in Block 5, said Santa Fe Tract to the southwest

corner of Lot 5, said Block 5, Santa Fe Tract; thence northerly along the West line of Lot 5 to the northwest corner thereof and the south line of East 11th Street, thence westerly on the south line of East 11th Street, produced Westerly, to the east line of Block 6, said Santa Fe Tract; thence southerly along the said east line of Block 6 to the southeast corner of said Block and the North line of East 12th Street; thence easterly along the north line of east 12th Street, produced easterly, to the southwest corner of Lot 6, said Santa Fe Tract and the point of beginning.

The above described parcel being all of that certain alley lying between the southerly side of East 11th Street and the northerly side of East 12th Street, between Block 5 and 6 of the Santa Fe Tract as per map of record in Book 6 of Maps, page 14, San Bernardino County, California records.
