1 SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, does hereby remise,
2 release and quitclaim unto the person or persons legally entitled thereto, all
3 rights acquired under or by virtue of that certain Grant of Easement from
4 Anza Realty Company to Southern California Edison Company dated September 6,
5 1949 (and recorded in Book 1107, page 31 et seq., of Official Records, records
6 of the County of Riverside, State of California,) insofar and only insofar as
7 said rights affect the following described real property:

8 Lots 33 to 42, inclusive, Lots 44 to 52, inclusive, and Lot 55 of Camp
9 Anza Subdivision No. 1, as per map recorded in Book 22, pages 81 and 82, of
10 Maps, in the office of the County Recorder of said County of Riverside.
11 EXCEPTING THEREFROM the Northerly 12 feet of said Lots 33 to 42, inclusive, and
12 the Southerly 5 feet of said Lots 44 to 52, inclusive, and the Northerly 5
13 feet of said Lot 55.

14 The rights hereby quitclaimed are not necessary or useful in the perform-
15 ance of the duties of said Southern California Edison Company to the public.


