

1 We, C. M. LORING and *Florence Barton* LORING, his wife, 116
 2 hereby GRANT to the CITY OF RIVERSIDE, a municipal corpora-
 3 tion of the sixth class, organized and existing under the laws
 4 of the State of California, all that certain real property,
 5 situate, lying and being in the City of Riverside, County of
 6 Riverside, State of California, bounded by a line described
 7 as follows, to-wit:-

8 Beginning at a point on the Westerly line of Lot Six (6),
 9 Block Eighteen (18) of the "Re-survey of a Portion of Rubidoux
 10 Heights", as surveyed by Shepard and Teilman, a map of which
 11 is of record in the office of the County Recorder of the Coun-
 12 ty of San Bernardino, and distant Forty (40) feet from the
 13 South-westerly corner of said Lot Six (6); thence in an East-
 14 erly direction and on the arc of a circle having a radius of
 15 Three Hundred and Fifty (350) feet, and convex toward the
 16 South to a point on the Southerly line of Seventh Street,
 17 which said point is the common corner of Lots Six (6) and Five
 18 (5) of said Survey; thence North-westerly and along the North-
 19 erly line of Lot Six (6), Forty-seven and Twenty-five hun-
 20 dredths (47.25) feet; thence in a Westerly direction and on
 21 the arc of a circle having a radius of Three Hundred and Ten
 22 (310) feet, and parallel to the above named curved line, and
 23 Forty (40) feet distant therefrom, to the Westerly line of
 24 said Lot Six (6); thence Southerly and along the Westerly
 25 line of Lot Six (6), to the point of beginning. The above
 26 description covers a strip of land Forty (40) feet wide and
 27 extending in a general Easterly and Westerly direction across
 28 said Lot Six (6).
