

GRANT DEED

1 C. H. PAULK and BESSIE M. PAULK, his wife, and ALICE E. THOMAS, a
2 widow, Grantors, for a valuable consideration, receipt of which
3 is hereby acknowledged, to hereby grant to CITY OF RIVERSIDE, a
4 municipal corporation, the real property in the City of Riverside,
5 County of Riverside, State of California, described as follows:

6 An undivided one-fifth interest in and to all of the following
7 described property:

8 That portion of Lot 1 in Block 25 of the Village of Arlington, as
9 shown by map recorded in Book 1 page 62 of Maps, San Bernardino
10 County Records, described as follows:

11 Beginning at a point on the Easterly line of said Lot 1, 1147 feet
12 Northerly from the intersection of the Easterly line of Lots 1 and
13 2 in said Block 25 with the Northerly line of the right of way of
14 the Lower Canal of the Riverside Water Company; thence Northerly
15 on said Easterly line of said Lot 1, 112½ feet; thence at right
16 angles Westerly and parallel with the Southerly line of Magnolia
17 Avenue, 330 feet to the Easterly line of Van Buren Street; thence
18 Southerly on said Easterly line of Van Buren Street, 112½ feet;
19 thence at right angles Easterly and parallel with the Southerly
20 line of Magnolia Avenue, 330 feet to the point of beginning.

21 That portion of the following described property lying Southeasterly
22 of that certain alley conveyed to the City of Riverside, by Deed
23 dated May 18, 1942, signed by LeRoy Hoffman and others, filed for
24 record June 27, 1942 as Instrument No. 1853, Riverside County
25 Records:

26 Commencing at the most Northerly corner of Lot 1 in Block 25 of
27 the Village of Arlington, as shown by map on file in Book 1 page
28 62 of Maps, San Bernardino County Records; thence Southwesterly
29 along the Southerly line of Magnolia Avenue, 50 feet; thence
30 Southeasterly and parallel with the Northeasterly line of Van
31 Buren Street, 150 feet; thence at a right angle Northeasterly and
32 parallel with the Southeasterly line of Magnolia Avenue, 50 feet
to the Northeasterly line of said Lot 1; thence at a right angle
Northwesterly along the Northeasterly line of said Lot 1, 150
feet to the point of beginning.

That portion of Lot 1 in Block 25 of the Village of Arlington, as
shown by map on file in Book 1 page 62 of Maps, San Bernardino
County Records, described as follows:

Beginning at a point on the Easterly line of said Lot 1, 1259½
feet Northerly from the intersection of the said Easterly line
of Lot 1 extended Southerly, with the Northerly line of the right
of way of the Riverside Water Company's Lower Canal; thence North-
erly on said Easterly line of Lot 1, 65 feet to a point 150 feet
Southerly from Magnolia Avenue; thence Westerly at a right angle
330 feet to the Westerly line of said Lot 1; thence at a right
angle Southerly on the said Westerly line, 65 feet; thence at a
right angle Easterly, 330 feet to the point of beginning;

EXCEPTING therefrom that portion thereof conveyed to the City of
Riverside, by Deed dated May 18, 1942, signed by LeRoy Hoffman
and others, filed for record June 27, 1942 as Instrument No. 1853,
Riverside County Records.
