2 RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY
3 OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS
4 AND DETERMINATIONS IN THE MATTER OF ORDINANCE OF
5 INTENTION NO. 1861; AND ORDER OF VACATION IN THE
6 MATTER OF VACATING A CERTAIN STREET COMMONLY KNOWN
7 AS Ellair Place.

8 WHEREAS, the Mayor and City Council of the City of Riverside,
9 California, adopted an ordinance of intention No. 1861, pursuant
10 to the provisions of the Street Vacation Act of 1941, being Part 3,
11 Division 9 of the Streets and Highways Code of the State of Cali-
12 fornia, declaring its intention to vacate a certain street commonly
13 known as Ellair Place, therein and hereinafter described; and,

14 WHEREAS, the matter came on regularly for hearing before said
15 Mayor and Council at the time and place fixed for hearing by said
16 ordinance of intention, and said Mayor and Council heard and
17 considered all of the evidence submitted.

18 NOW, THEREFORE, BE IT RESOLVED by said Mayor and Council that
19 it be and is hereby found and determined by said Mayor and City
20 Council that said ordinance of intention was duly passed, adopted,
21 and posted in the manner prescribed by law for the adopting and
22 posting of ordinances of said City, and the notice of said vaca-
23 tion proceedings and of the time and place of hearing was given
24 by posting, as provided by the Street Vacation Act of 1941, and
25 that the said public street therein described is unnecessary for
26 present or prospective public purposes and should be vacated.

27 NOW, THEREFORE, pursuant to the provisions of the said Street
28 Vacation Act of 1941 it is hereby ordered by the Mayor and City
29 Council of the City of Riverside, California, that that certain street
30 commonly known as Ellair Place in the City of Riverside, County
31 of Riverside, State of California, described as follows, to wit:

32 All of that public street in the City of Riverside and
shown on a map of Lochmoor Heights as Ellair Place, said
map being recorded in Map Book 14, at page 6, Records of
Riverside County, California;

2 or rights therein.

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF ORDINANCE OF INTENTION NO. 1861 : AND ORDER OF VACATION IN THE MATTER OF VACATING A CERTAIN STREET COMMONLY KNOWN AS Ellair Place.
