

GRANT DEED

1 CITIZENS NATIONAL TRUST AND SAVINGS BANK OF RIVERSIDE, As Trustee,  
2 a national banking association, Grantor, for a valuable considera-  
3 tion, receipt of which is hereby acknowledged, does hereby grant  
4 to CITY OF RIVERSIDE, a municipal corporation, the real property  
5 in the City of Riverside, County of Riverside, State of California,  
6 described as follows:

7 An undivided one-fifth (1/5) interest of all of the following  
8 described property:

9 That portion of Lot 1 in Block 25 of the Village of Arlington,  
10 as shown by map recorded in Book 1, page 62 of Maps, San Bern-  
11 ardino County Records, described as follows:

12 Beginning at a point on the Easterly line of said Lot 1,  
13 1147 feet Northerly from the intersection of the Easterly line  
14 of Lots 1 and 2 in said Block 25 with the Northerly line of  
15 the right of way of the Lower Canal of the Riverside Water  
16 Company; thence Northerly on said Easterly line of said Lot 1,  
17 112½ feet; thence at right angles Westerly and parallel with  
18 the Southerly line of Magnolia Avenue, 330 feet to the Easterly  
19 line of Van Buren Street; thence Southerly on said Easterly  
20 line of Van Buren Street, 112½ feet; thence at right angles  
21 Easterly and parallel with the Southerly line of Magnolia Ave-  
22 nue, 330 feet to the point of beginning.

23 That portion of the following described property lying South-  
24 easterly of that certain alley conveyed to the City of Riverside,  
25 by Deed dated May 18, 1942, signed by LeRoy Hoffman and others,  
26 filed for record June 27, 1942, as Instrument No. 1853, Riverside  
27 County Records:

28 Commencing at the most Northerly corner of Lot 1 in Block 25  
29 of the Village of Arlington, as shown by map on file in Book 1,  
30 page 62 of Maps, San Bernardino County Records; thence South-  
31 westerly along the Southerly line of Magnolia Avenue, 50 feet;  
32 thence Southeasterly and parallel with the Northeasterly line  
of Van Buren Street, 150 feet; thence at a right angle North-  
easterly and parallel with the Southeasterly line of Magnolia  
Avenue, 50 feet to the Northeasterly line of said Lot 1; thence  
at a right angle Northwesterly along the Northeasterly line of  
said Lot 1, 150 feet to the point of beginning.

That portion of Lot 1 in Block 25 of the Village of Arlington,  
as shown by map on file in Book 1, page 62 of Maps, San Bernard-  
ino County Records, described as follows:

Beginning at a point on the Easterly line of said Lot 1,  
1259½ feet Northerly from the intersection of the said Easterly  
line of Lot 1 extended Southerly, with the Northerly line of  
the right of way of the Riverside Water Company's Lower Canal;  
thence Northerly on said Easterly line of Lot 1, 65 feet to a  
point 150 feet Southerly from Magnolia Avenue; thence Westerly  
at a right angle 330 feet to the Westerly line of said Lot 1;  
thence at a right angle Southerly on the said Westerly line, 65  
feet; thence at a right angle Easterly, 330 feet to the point  
of beginning;

EXCEPTING therefrom that portion thereof conveyed to the City  
of Riverside, by Deed dated May 18, 1942, signed by LeRoy  
Hoffman and others, filed for record June 27, 1942, as Instrum-  
ent No. 1853, Riverside County Records.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A DEED


