

GRANT DEED

ERNEST A. PELLISSIER and ETHEL PELLISSIER, husband and wife, and
FLORENCE RADNEY, formerly Florence Pellissier, Grantors,

For a valuable consideration, receipt of which is hereby acknowledged, do hereby grant to CITY OF RIVERSIDE, a municipal corporation, the real property in the County of San Bernardino, State of California, described as follows:
(Rider attached to deed as follows)

An undivided one-tenth interest in and to the following described property:

PARCEL 1:

All that portion of Lot 46, according to Map of Subdivision of the BANINI DONATION, as per plat recorded in Book 3 of Maps, page 24, of the records of said County, lying North of the North line of Lot 47 and North of the extension of the said Northline of Lot 47, to the East and West lines of said Lot 46, as said part of Lot 46 is shown on plat of survey by Geo. M. Pearson, on file in the office of the County Recorder of said County, estimated to contain 22-1/2 acres.

PARCEL 2:

Lots 40, 41, 45, 45-1/2 and 47, according to Map of Subdivision of the BANDINI DONATION, as per plat recorded in Book 3 of Maps, page 24, records of said County.

PARCEL 3:

RESOLUTION NO. 7567

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A DEED.

BE IT RESOLVED, that a Grant Deed dated December 19, 1956, executed by Ernest A. Pellissier, Ethel Pellissier, and Florence Radney, granting to the City of Riverside, a municipal corporation, an undivided one-tenth interest in and to water and water right situate in the "Trujillo" or "Spanish-Town" Ditch, said Ditch being situate in the Counties of San Bernardino and Riverside, State of California, and said Ditch being entitled to a continuous run of One hundred inches of water, said right being more particularly shown in Case #579, in the Superior Court of the County of San Bernardino, State of California, as per Judgment recorded in the County Clerks office of said County and State in Book #2 of Judgments, page #102. The water herein conveyed is Fourteen (14) hours of the said water and water right of One hundred inches, the turn coming once every Eleven days, be, and the same is hereby, officially accepted.
