WITNESSETH: That the said party of the first part, for and in consideration of the sum of \$113.60, lawful money of the United States of America to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the said party of the second part, and to its heirs, and assigns forever, all that certain lot, piece or parcel of land situate, lying and being in the City of Riverside, County of San Bernardino, State of California, and bounded and particularly described as follows, to-wit:-

Commencing at the Southwest corner of Lot #44, thence extending in a northerly direction along the Westerly line of Lot #44, 660 feet; thence Northerly along the Westerly line of Lot #45, 330 feet; thence at right angles in an Easterly direction 25 feet; thence at right angles in a Southerly direction 990 feet; thence at right angles in a Westerly direction 25 feet to point of beginning. All contained in lands of the Southern California Colony Association, as surveyed by Goldsworthy & Higbie, C.
