SLOPE EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
FAYE H. ENG, a married woman, as her sole and separate property,

as Grantor, grant(s) to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for roadway slope and support purposes, in, on, under, through, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 12 in Block 9 of The Lands of the Riverside Land & Irrigating Co., on file in Book 1 of Maps, at Page 70 thereof, records of San Bernardino County, California, more particularly described as follows:

COMMENCING at the intersection of the centerline of Van Buren Boulevard with the centerline of California Avenue;

THENCE North 34° 16' 02" West, along said centerline of Van Buren Boulevard 976.17 feet;

THENCE North 55° 43' 58" East, 47.00 feet to its intersection with a line which is parallel with and distant 47.00 feet northeasterly, as measured at right angle, from said centerline of Van Buren Boulevard; said intersection being the beginning of a tangent curve with a radius of 953.00 feet, concaving easterly and being tangent to said parallel line;

THENCE Northeasterly along said curve an arc length of 90.83 feet, thru a central angle of 05° 27' 38" to the northwesterly line of that certain parcel of land conveyed to Francis Earl White, Jr., et ux., by deed recorded July 15, 1948, as Instrument No. 2006 of Official Records of Riverside County and to the true point of beginning;

THENCE continuing Northwesterly along said curve an arc length of 121.40 feet, thru a central angle of 07° 17' 55" to the northwesterly line of that certain parcel of land conveyed to Leslie J. Burke, et ux., by deed recorded November 17, 1947, as Instrument No. 1833 of Official Records of said Riverside County;

THENCE North 55° 42' 45" East, along the northwesterly line of said parcel of land so conveyed to Leslie J. Burke, et.,

ux., a distance of 5.13 feet to the beginning of a non-tangent curve, with a radius of 948.00 feet, concaving easterly and being concentric with hereinabove described curve;

THENCE Southeasterly along said non-tangent curve an arc length of 121.42 feet, thru a central angle of 07° 20' 18" to the northwesterly line of said parcel so conveyed to Francis Earl White, Jr.;

THENCE South 55° 45' 07" West, along said northwesterly line 5.02 feet to said true point of beginning.

Said slope and support easement is to be used for all purposes proper and convenient in the construction, reconstruction and maintenance of roadway slopes and supports, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Provided, however, that the Grantor(s) reserve(s) the right of use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.
