ORDINANCE NO. 5108

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 13393, AND MAKING ITS ORDER CLOSING TO VEHICULAR ACCESS ONLY THE ALLEY LYING PARALLEL TO UNIVERSITY AVENUE IN THE BLOCK BOUNDED BY ORANGE AND NINTH STREETS, THE MALL AND UNIVERSITY AVENUE.

WHEREAS on February 28, 1978, the City Council of the City of Riverside adopted Resolution No. 13393 declaring its intention to order the closure to vehicular access only at its intersection with Orange Street and at its intersection with the North-South Alley, that alley lying parallel to University Avenue in the block bounded by Orange and Ninth Streets, the Mall and University Avenue, and fixing the time and place of hearing all persons interested in the proposed closure, pursuant to the procedural provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed closure was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing on said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that vehicular access to the system of City streets from that alley lying parallel to University Avenue in the block bounded by Orange and Ninth Streets, the Mall and University Avenue, through its intersection with Orange Street or through its intersection with the North-South Alley, is unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT ORDAINED by the City Council of

the City of Riverside, California, that at its intersection with Orange Street and at its intersection with the North-South Alley, that alley lying parallel to University Avenue in the block bounded by Orange and Ninth Streets, the Mall and University Avenue in the City of Riverside, County of Riverside, State of California, is hereby ordered closed to vehicular access only, the method and exact location of the closure to be determined by the City Engineer in the best interests of the health, welfare and safety of the City.

IT IS FURTHER ORDAINED that the City Clerk of said City of Riverside shall cause a certified copy of this order attested by the City Clerk under the seal of said City to be recorded in the office of the County Recorder of Riverside County, California.






