FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
do ___ hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation,
the real property in the City of Riverside, County of Riverside, State of
California, described as follows:

That portion of the West one-half of Section 3, Township 3
South, Range 6 West, S.B.M. as shown by map of a subdivision
of Rancho La Sierra on file in Book 6 of Maps, at Page 70
thereof, records of Riverside County, California, described
as follows:

COMMENCING at the southerly terminus of that certain course
in the westerly boundary line of Tract 8796-1 as shown on map
on file in Book 132 of Maps, at Pages 96 through 100 thereof,
records of Riverside County, California, that bears North 08°
33' 00" West, a distance of 1236.36 feet;

THENCE Southwesterly along said westerly line on a curve concave
westerly, having a radius of 190.00 feet through a central angle
of 40° 09' 52", an arc length of 133.19 feet to an angle point
in said boundary, said angle point being on the westerly line


