FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
ROSE GARDEN VILLAGE NO. 2, a California non-profit corporation,

as Grantor, grants to the CITY OF RIVERSIDE, a Municipal Corporation
of the State of California, as Grantee, its successors and assigns, a
perpetual easement and right of way for the construction, reconstruction,
maintenance, operation, inspection, repair, replacement, relocation,
renewal and removal of electrical energy distribution facilities

together with all necessary appurtenances, in, under, upon, over and
along that certain real property situated in the City of Riverside,
County of Riverside, State of California, described as follows:

That portion of Lot 1 in Block 23 of the Lands of the Riverside
Land and Irrigating Company, as shown by map on file in Book
1 of Maps at Page 70 thereof, records of San Bernardino County,
California, being more particularly described as follows:

BEGINNING at a point in the northwesterly line of said Lot 1,
distant thereon South 56° 00' 00" West 202.00 feet from the
most northerly corner thereof, said point also being the most
northerly corner of that certain parcel of land conveyed to
Rose Garden Village No. 2 by Deed recorded September 28, 1978
as Instrument No. 205985, Official Records of Riverside County,
California;

THENCE continuing South 56° 00' 00" West, a distance of 12.00
feet to a line which is parallel with and distant 6.00 feet
northeasterly as measured at right angle from the northeasterly
line of that certain parcel of land conveyed to Robert D.
Miller, et al., by Deed recorded October 13, 1978 as Instrument
No. 216817, Official Records of said Riverside County;

THENCE South 33° 59' 37" East, along said parallel line a
distance of 400 feet to the northeasterly prolongation of the
southeasterly line of last said parcel of land;

THENCE North 56° 00' 00" East, along said prolongation a
distance of 12.00 feet to a line which is parallel with and
distant 18.00 feet northeasterly, as measured at right angle
from the northeasterly line of said parcel conveyed to Robert
D. Miller, et al.;

THENCE North 33° 59' 37" West, along said parallel line a
distance of 400.00 feet to the Point of Beginning.

Provided, however, that the Grantor reserves the right to use and enjoy the land over which said easement and right of way is granted, or any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.
