7 BE IT RESOLVED by the City Council of the City of
8 Riverside, California, that the strips or parcels of land
9 located in the City of Riverside, County of Riverside, State of
10 California, and owned by the City of Riverside, being a portion
11 of the Gage Canal right-of-way, described in Exhibit A,
12 attached hereto and incorporated herein by this reference,
13 are hereby dedicated by the City of Riverside for public use
14 for street purposes to become and be known as portions of
15 Fairview Avenue.



Legal Descriptions for Resolution of Acceptance for Street Purposes
of Portions of Gage Canal in Conjunction with Tract 19236.

Parcel 1

That portion of the Northeast one-quarter of Section 36, Township 2 South, Range 5 West, S.B.M., described as follows:

COMMENCING at the most northerly corner of Parcel 2 of Map on file in Book 52 of Record of Surveys at Pages 4 through 8 thereof, Records of Riverside County, California;

THENCE South $72^{\circ} 26' 47''$ East along the northeasterly line of said Parcel 2, also being the southwesterly line of the Gage Canal right-of-way as shown on said Record of Survey map, a distance of 54.40 feet to the point of beginning of the parcel of land to be described;

THENCE Southeasterly, Northeasterly and Northwesterly on a curve concave northwesterly, having a radius of 15.50 feet, through an angle of $149^{\circ} 35' 17''$, an arc length of 40.47 feet to a point of compound curvature;

THENCE Northwesterly on a curve concave southwesterly, having a radius of 193.50 feet, through an angle of $16^{\circ} 43' 45''$, an arc length of 56.50 feet to the northeasterly line of said Gage Canal right-of-way (the initial radial line bears North $47^{\circ} 57' 56''$ East);

THENCE South $72^{\circ} 26' 47''$ East along said northeasterly line, a distance of 65.57 feet;

THENCE South $41^{\circ} 32' 09''$ East, a distance of 47.15 feet;

THENCE Southeasterly on a curve concave northeasterly, having a radius of 181.50 feet, through an angle of $30^{\circ} 54' 38''$, an arc length of 97.92 feet to a point of cusp in the southwesterly line of said Gage Canal right-of-way;

THENCE North $72^{\circ} 26' 47''$ West along said southwesterly line, a distance of 154.92 feet to the point of beginning.

Area: 3, 313 Square Feet.

Parcel 2

That portion of the Northeast one-quarter of Section 36, Township 2 South, Range 5 West, S.B.M., described as follows:

COMMENCING at the most northerly corner of Parcel 2 of Record of Survey on file in Book 52 at Pages 4 through 8 thereof, records of Riverside County, California;

THENCE South $72^{\circ} 26' 47''$ East along the northeasterly line of said Parcel 2, also being the southwesterly line of the Gage Canal right-of-way as shown on said Record of Survey, a distance of 326.33 feet to the point of beginning of the parcel of land to be described;

THENCE continuing South $72^{\circ} 26' 47''$ East, a distance of 103.79 feet to the southwesterly line of said Gage Canal right-of-way;

THENCE South $87^{\circ} 50' 32''$ West along said southwesterly line, a distance of 30.54 feet to an angle point therein;

THENCE North $64^{\circ} 37' 56''$ West continuing along said southwesterly line, a distance of 75.75 feet to the point of beginning.


